#### 1. Welcome, agreement on agenda, and Presidents Report (Greg/Jan)

Jan Leach and Greg Johnson welcomed attendees. Greg Johnson talked to the IY PH 2020 and the task force

#### 2. Future of the Task Force and Congress Challenge

Serge Savary gave feedback regarding SMCs. There is a perception from the SMCs that they do not have a role in the ISPP/ICPP. In a survey the SMC chairs were asked if they knew that Food Security is the journal of ISPP. In all cases none of the SMC chairs were aware that Food Security was the ISPP journal. This serves to illustrate the fact that we need to engage more effectively with the SMC chairs, and promote the journal more broadly.

In another survey this time of APS colleagues none knew what the "symbol/logo" of the ISPP was. This serves to illustrate the fact that our communication with many of the ISPP members is not effective. There was a suggestion that at the very least we need to have the words ISPP in the logo. In fact we should be overall rethinking our logo.

Daniel Huberli was asked to comment about the idea and reality of producing a new logo. He reflected that the current logo cannot be expanded very much (for large banners and projections). The solution is that it needs to be "vectorized" to solve this problem.

The history of the logo was that it was done for the second ICPP meeting but there is general consensus that we need a new logo and thus need to decide how we take this forward. It was suggested that the organisers of the Lyon meeting should develop a "refreshed" logo which could then be absorbed by ISPP. Thus the organising committee of the ICPP 2023 were tasked to drive the development of the new logo.

Some suggestions as to how to take this forward was that there would be a survey. Serge Savary undertook to develop the survey questions (is logo okay; what needs to be changed; are the colours appropriate etc....).

Survey would be circulated through the newsletter. The Lyon meeting would then be used as a springboard to design the new logo – which then would be launched at the 2023 meeting.

Action 1 – Serge Savary and Daniel Huberli to do survey regarding logo Action 2 - Nathalie Poussereau, Mathias Choquer to drive development of new logo – based on recommendations from the survey

#### 3. Committees

Serge Savary reported that the idea to have an SMC chairs meeting at the ICPP meeting was a good one. The SMCs were happy with this idea and the meeting was a good one. Serge Savary reported that we need to give the SMC chairs more recognition – there was a suggestion that we should have a page on the website with photos of the SMC chairs. It was suggested that there would be a newsletter article to introduce the SMC chairs. Daniel Huberli will engage with the chairs.

Action 3 – Daniel Huberli to undertake newsletter article introducing SMC chairs

#### 4. Financial support and items from committee reports.

The first issue that was discussed was about the financing of the purchase of the journal. This is in principle on track.

Serge Savary requested that there should be a meeting of the editors of the journal. As he is taking over as Editor in Chief there needs to be a meeting between him and the other senior editors. This is currently six people, they are across the world, Netherlands (Wageningen), Scotland (Edinburgh), USA (Michigan and Texas), Belgium (Brussels), Mexico and France. Serge Savary was asked to provide a budget for such a meeting for consideration.

- 5. Items from Councillor's and Subject Matter Committee Chair's suggestions. Discussion around the items raised at the council meeting. These need to be officially responded to at the next council meeting. (text below taken from minutes of Council meeting)
  - (i). There was a question as to why there were so many new Fellows in comparison to passed ICPP meetings. Greg Johnson answered to the satisfaction of those present, noting that ISPP Fellows are only elected at ICPP (i.e. every five years). The reasons included the fact that there previously had not been quite so many nominations. The ISPP had undertaken to publicize the nomination of Fellows more widely and this is possibly why there have been more nominations and thus more Fellows than in the past. This is considered to be positive and an indication that the ISPP is reaching more people through a number of interventions than in the past.
  - (ii). There was a question as to what the priorities of Task Force 2050 will be. It was explained that this task force will be an opportunity to profile Plant Pathology, especially with regards to IYPH 2020 but also beyond. The priorities of the task force still need to be developed.
  - (iii). Ralph Lopian (invitee representing IYPH2020) also suggested that in light of IYPH 2020 that the legacy /outcome in terms of public awareness should be considered. This is particularly with regards to collaborative research and that funds for research should be used better than they have been in the past. Also suggested that ISPP interact with the IPPC (International Plant Protection Convention Commission) IYPH2020 steering committee and the FAO (Food and Agriculture Organization) to facilitate these kinds of collaborations.
  - (iv). There was a question from David Olufolaji regarding how ISPP could support research in the developing world. Bursaries to attend the ICPP meeting while appreciated are not enough. ISPP could also assist in providing opportunities for Africans to visit laboratories in the more "developed world".
  - (v). There is a "One Arctic One Health" conference in 2019<sup>1</sup>. Plant Health is missing from this meeting yet it includes "health of environment, wildlife, domestic animals and humans". Jennifer McBeath suggested that there needs to be more effort to include Plant Health as this and equivalent meetings.
  - (vi). Mike Wingfield asked if there are Plant Pathology Societies which are not members of ISPP. South America is certainly a challenge, some of the European Societies are not members, Cuba also seems not to be a member. Suggestion that part of the IYPH 2020 that all societies should be tasked to assist in identifying non-member organisations and facilitating ISPP membership. (next APS Caribbean Division Meeting is in Cuba (https://www.apsnet.org/members/divisions/carib/meetings/Pages/default.aspx))

(vi). It was also suggested that regional Plant Protection organisations could be used to reach out to Plant Pathologists. In addition Councillors could be asked to reach out in regions that they are from to encourage joining ISPP.

There was also the suggestion of "a plant pathologists pledge" raised by Sophien Kamoun and Lodovica Gullino (test taken from council minutes)

It was suggested that there should be a Plant Pathologists pledge, a code of conduct similar to that undertaken by the medical professions – "to do no harm". This issue is particularly important in the case of emergencies. A draft was circulated and there was some discussion about the suggestion as well as the draft documents. There was a suggestion that IPPC could look at it to see if it complied with international regulations. Also need to consider role of Twitter etc – these forms of communication can be useful but are also challenging. There was a suggestion that ISPP needs to also consider government protocols and procedures. There is a need to also consult with the entomologists. ISPP executive will take this draft forward and get feedback from the ISPP membership prior to a formal vote. This will be done through the ISPP newsletter.

There was then some discussion around the ideal structure of the council meeting. It was suggested that the meeting could be held in a different way to accommodate different ways of expression by the different councillors. It was mentioned that while there is only one council meeting every 5 years that the ISPP President does engage with the various councillors at other meeting in the "in between" years.

It was suggested that we should encourage some more social engagement between the councillors to allow for some mixing. We could also try to highlight some of the smaller societies at the next council meeting. We particularly need to engage with societies in the Arab regions as our participation with these regions is particularly low. For the Boson meeting this might also reflect difficulties in obtaining visa's to enter the USA.

Given the realities of climate change and particularly its impact on the Artic it might be important to consider an SMC on Artic and cold environments.

Lise suggested that she could lead a position paper on "one health".

SMC feedback is given under (4).

Action 4: Subcomittee to be established for Plant Pathologist Pledge (could also include an article in the ISPP newsletter) – Sophien Kamoun and Lodovica Gullino/Daniel Huberli.

Action 5: Khaled Makkouk to engage with Serge Savary regarding the suggestion of another SMC – one on Artic and Cold environments.

Action 6: Lise Korsten to lead a position paper on "one health".

#### 6. Memberships and Invitations

No additional discussion on this topic – some discussion above.

#### 7. Report from the ICPP2023 committee (Mathias and Nathalie)

There was some discussion about how we can ensure that attendees at ICPP2023 stay for the full 5 days of the meeting. Tom Evans (APS committee chair) was asked to provide a debriefing documents on ICPP2018. Tom Evans noted that there will also be an E-mail survey after the ICPP2018 meeting which can also be shared. (Tom Evans reported that 2410 people registered for ICPP2018). It was also suggested that we ask APS if we could use the APS App for the 2023 meeting.

Action 7: Tom Evans to provide Nathalie Poussereau with debriefing documents and engage with APS regarding the use of the App for the 2023 meeting.

There was additional discussion around some of the other potential challenges regarding session and content of sessions. We can ask the SMC chairs specifically to assist with session topics.

#### 8. **Suggestions for the Website www.isppweb.org** (Peter Williamson)

Andrea Masino with take over some aspects of the website. There was a suggestion that we need to better (more obviously) advertise the ISPP journal on the web site. We could also look at improving aspects of the home page of the website.

#### 9. Forward strategy (Jan)

Jan Leach talked to the strategy for the next five years. She suggested that we should consider using the SDGs as a driver to support the task force. Also that we need to press forward with initiative linked to the IYPH 2020. We also need to investigate how we can assist the international Plant Pathology community. ISPP could have a powerful voice especially in the international community and we need to use this.

Jan Leach suggested that the initial focus should be on the journal and the newsletter. It is important that we support both. Andrea Masino is tasked to start a LinkedIn page, we can also investigate social media platforms such as Research Gate and Facebook (ISPP already has a presence on Facebook).

#### Action 8: Andrea Masino is tasked to start a LinkedIn page for ISPP

#### 10. New Business (Jan)

Jan Leach asked whether ISPP members and ICPP attendees are automatically subscribed to ISPP newsletter. Nobody could supply a definitive answer and it was suggested that we needed to ask Peter Williamson. It was suggested that we need to put out an article in the APS news about the ISPP newsletter.

There was a suggestion that the Newsletter could be redesigned to make it visually more stimulating.

Action 9: Andrea Masino to ask Peter Williamson as to whether ISPP members and ICPP attendees are automatically subscribed to newsletter Action 10: Daniel Huberli to contact APS (with assistance from Tom) about putting an article in APS news about ISPP newsletter

Action 11: Daniel Huberli to consider ways of making ISPP newsletter more attractive.

#### 11. EC Meetings 20018-2023 (Jan/Brenda)

There was a discussion about the next ISPP EC meeting. Suggestions were, Glasgow 2019, APS 2019 or APPS in Melbourne 2019. Consensus was that the majority (but not all) would be able to make the APPS meeting (25<sup>th</sup> – 28<sup>th</sup> Nov 2019). It was also mentioned that some EC members will be attending a meeting in Vienna in 2019. It was also mentioned that the 58th Meeting of the APS Caribbean Division will be held in Cuba May 6-10, 2019. EC members are encouraged to network with ISPP members and especially the councillors when they attend meetings across the globe.

#### 12. Adjourn

The meeting was adjourned. Jan Leach thanked everyone (including current and previous ISPP EC) for their attendance and participation. It was noted that the baseball that APS had presented to ISPP would go with Jan Leach to Colorado for safe keeping.
